6. No admissions shall be made in excess of the intake sanctioned by the University. Such Admissions shall be invalid as per section 59(18) of K.S.U. Act. 2000
7. No transfer of admissions shall be made without the prior approval of the University.
8. No Admission shall be made after the last date fixed for admission by the University and any Admission to a course after the last date shall automatically become invalid.
9. The Principal/Head of the institutions are requested to notify this calendar for the information of all staff and students of the institutions.
10. In the event of any of the above date being holiday, the activity shall commence on the next working day.
